## Helping Orangutans Even When You No Longer Share Their World

Including OFI in your estate plans is a special way you can continue to improve their world. Your gift will provide long-term support to ensure the continuing operation of our organization.

### You can designate OFI as a:

- Direct beneficiary of specific assets within your estate;
- General beneficiary of a portion or percentage of your estate; or
- Contingent beneficiary of assets designated for loved ones, should they not survive you.

There are many ways to support OFI through estate planning

### Outright bequest

You may bequeath cash, securities, jewelry, or any other personal property to OFI. Non-cash assets will generally be converted to cash.

### Devise of real estate

You can bequeath real estate, land, or buildings to OFI. As a general principle, any real estate bequeathed to OFI will be converted to cash.

### Beneficiary designation

You can name OFI as the beneficiary of a life insurance policy or bank account.

### Trust beneficiary

You can name OFI as either the beneficiary of the income from a trust or beneficiary of a trust at its termination.
